Transactional Document Management

AccessibilityNow® Transactional transforms transactional documents into accessible formats through a fully automated tagging process.

- Set up rules for creating accessible documents with AccessibilityNow® Designer, a GUI driven design tool.
- Output PDF/UA, WCAG PDF, and/or Accessible HTML.
- Make high volume transactional documents, such as invoices and statements, into accessible digital and traditional alternate formats.

Static Document Management

AccessibilityNow® Publisher provides rapid accommodation of published documents. These documents are typically static as opposed to transactional.

- Automatically tag and convert documents such as marketing literature, letters, books, manuals, and other communications into WCAG PDF, PDF/UA and/or Accessible HTML5.
- If additional operations are needed, such as adding alternate text to graphics, or changing the reading order, AccessibilityNow® Remediate, a GUI driven tool, can be used for tag-finishing.

Website Document Scanning and Validation

Examine website content for document compliance.

- AccessibilityNow® DocMD crawls websites, finds all documents and determines which are compliant and which are not. If not compliant, AccessibilityNow® Publisher and/or AccessibilityNow® Remediate can be used for the remediation process.
